



USPS COVID-19 Operational Impacts

- Limited impact on domestic services
 - International impacts vary
 - Loss of lift, modal/other transportation changes
- Change in signature policy
- Piloting/testing remittance redirect
- Forwarding/hold policies
- "Digital only" ID?

COVID-19 Legislative Response

- Senate passed legislation
 - \$10Bn in borrowing authority for USPS
 - Operating expenses only
 - Emphasize delivery of emergency goods
 - House OGR members unimpressed
- House proposal coming
 - Debt forgiveness
 - Vote by mail
 - Revenue foregone provision
